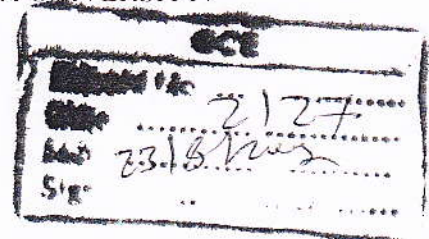

Sir,

All India Council for Technical Education has published a Booklet known as Hand Book For Approval process, which is a Legal Document as per "Section (5) of Gazetted Policy Resolution No. F.37-3/Legal (iv) 2002 of AICTE dated November 20, 2002 published on November 25, 2002 in the Gazette of India, Extraordinary, Part-III, Section-4".

In this Approval Process Hand Book, there is a chapter known as "Policy Decision by the Executive Committee (EC) of AICTE". Under these "Policy Decisions", there is a heading known as "STATUS OF COURSES NOT MENTIONED IN APPROVAL LETTER" which states that "If an institution submits application/proposal to conduct several courses and AICTE decides, after processing the proposal/application as per laid down procedure, to accord approval for some specified courses(s) with specified intake capacity for each course which is/are less than the number of courses proposed and/or less than the intake proposed for each course, the course and / or the proposed intake for which approval is not accorded, will automatically stand rejected, whether a separate Rejection letter is issued or not".
