... the event of infringement/contravention or non-compliance of any of the conditions, guidelines, norms, and regulations prescribed by the AICTE from time to time the AICTE or a body or person(s) authorised by it shall be free to take measures for mithdrawal of the approval recognition without consideration of any related issues and that liabilities arising out of such withdrawal would be solely that of the anagement/Irust/Society and/or Institutions. AICTE may inspect the institution at any time it may deem fit to note progress.

Specific Conditions:

- While ensuring optimal utilisation of resources, adequacy of resources for each course (i.e. degree and polytechnic institute) be ensured.
- Additional investment should be made for improving the Institution infrastructural/instruction facilities (Land, Building, Staff residence, Hostels etc.) and to meet the annual recurring expenditure.
- 3. The teaching faculty and technical supporting staff should be recruited to bring it at par with the AICTE norms within 06 months.
- 4. The equipments in labs/workshop need strengthening so as to confirm to AICTE norms. (Minimum investment Rs. 20 lakhs within 12 months).
 - 5. Library facilities in terms of text books, reference books, etc. need augumentation to conform to AICTE norms. (Minimum investment of Rs. 10 lakhs within 06 months.)
 - Audited Balance Sheet, Income-Expenditure report, Auditors report of the Institution for 1993-94 is not furnished which should be furnished immediately to Western Regional Office of AICTE.
 - 7. Audited balance sheet, Income-expenditure report, Auditors report of the institution for 1994-95 should be furnished to Western Regional Office of AICTE by July 1995.
